- **個人資料私隱**

- **個人資料的查閱及更正**

根據《個人資料（私隱）條例》，你有權要求查閱及改正你所遞交的個人資料。如欲查詢有關本表格所收集的個人資料，包括要求查閱及改正資料事宜，須以書面方式向本校提出（電郵：[college@hkmakslo.edu.hk](mailto:college@hkmakslo.edu.hk)）。

- **Personal Data Privacy**

The Hong Kong Management Association K S Lo College (the School) is committed to complying fully with the relevant provisions of the Hong Kong Personal Data (Privacy) Ordinance in handling and safeguarding the personal information you provide. This Personal Information Collection Statement outlines the purposes for which your personal data will be used, as well as your rights regarding its use by the School.

- **Purpose of Collection of Personal Data**

To apply for Secondary 1 (S1) places, it is mandatory for applicants to provide personal data in the School's 'S1 Discretionary Places Application Form'. Parents registered as users of the Secondary School Places Allocation (SSPA) e-Platform through 'iAM Smart+' may also submit discretionary place applications via the SSPA e-Platform. All personal information provided in the application form will be used exclusively for the School's S1 admission process and will be submitted to the Education Bureau as required.

- **Access to and Correction of Personal Data**

Under the Personal Data (Privacy) Ordinance, you have the right to access and request corrections to the personal data you provide. Any enquiries related to the collected personal data, including requests for access or correction, should be submitted in writing to the School. - **Retention of Personal Data**

All personal data provided will be retained only for the duration of the admission process. Once the process is completed, the information you have submitted will be securely destroyed.
